The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed on the basis of land holding for any school.

Important Notes: 1. It has been observed from online application that school is running more sections (34) than the land available (4093 sq mtrs) available with school. Hence, the number of sections of the school are restricted to 28 as per Appendix V of existing Affiliation Bye Laws. Any increase in sections will be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws. 2. As per school campus videography uploaded, separators are not seen in between urinals of boys toilets. Hence, school is directed to construct proper separators in boys urinals and upload photo evidence in mandatory public disclosure of school website.

School is required to appoint special educator & wellness teacher as per affiliation bye laws.

The number of sections and students shall be restricted as per the actual facilities in the school.
